


Deodorant Clean-Up Washcloths	
Classification	Cleanser: Prepared Cloth
Key Points	<ul style="list-style-type: none"> • Disposable, pre-moistened, medium weight washcloths with aloe. • Fragrance free. • pH balanced. • Rinse free.
Indications	<ul style="list-style-type: none"> • For perineal cleansing following an incontinence episode (fecal and/or urinary).
Precautions	<ul style="list-style-type: none"> • For external use only. • Do not flush cloths or put in macerator. Dispose in garbage.
Contraindications	<ul style="list-style-type: none"> • Do not use with known allergy or sensitivity to any of the product ingredients.
Formats & Sizes	<ul style="list-style-type: none"> • Package of 3 (15 x 22 cm) cloths 
Application Directions	Rationale
Package is single patient use.	To minimize risk of cross-contamination.
To Apply	
<p>Use at room temperature or warm in Sage warmer. Only use microwave for warming if facility/unit policy allows.</p> <p>Sage warmer’s display system switch, found on back of warmer, should be set to “C” only if CHG Antiseptic Body Cleanser wipes are in warmer. If no CHG Antiseptic Body Cleanser wipes in warmer, the display system switch can be set to “B”. The coloured lights provide information on the heating status of the package adjacent to the light:</p> <ul style="list-style-type: none"> • Yellow light – package has not reached the target temperature. • Steady green light – package has reached target temperature. • Flashing green light – package has been at target temperature for 48 hours and should be used first. • Red light (only visible if display system switch is set to “C”) – package has been at target temperature for over 84 hours and CHG Antiseptic Body Cleanser wipes should be discarded and other wipes should be used first. <p>Once package has been removed from warmer and taken to client’s bedside, do not put back in warmer for re-warming.</p> <p>Warming in microwave is not recommended. Only use microwave for warming if facility/unit policy allows.</p> <ul style="list-style-type: none"> • Peel open label and place in microwave for no longer than 12 seconds. <p>Closely monitor heat level, especially with infants or unresponsive or skin-sensitive individuals. Do not use if excessively hot.</p> <p>Clean soiled area with fresh cloth and discard into garbage. Do not flush cloths or put in macerator.</p> <p>Repeat as often as necessary until area is clean.</p> <p>Do not rinse.</p>	<p>Warm cloths provide increased client comfort.</p> <p>All Sage products can be in the warmer with display system switch set to “C” as this does not impact temperature.</p> <p>Packages take approximately 2 hours to warm.</p>  <p>All wipes except CHG Antiseptic Body Cleanser Cloths are safe to use after 84 hours at target temperature.</p> <p>To reduce the risk of cross-contamination between clients.</p> <p>Inconsistent heating can occur. Microwave wattage varies. Adjust heating time accordingly.</p> <p>Use caution when determining heat level as gloves diminish sensitivity to heat.</p> <p>Cloths may plug/clog plumbing.</p>

Apply thin layer of skin protectant or skin barrier.	To decrease risk of incontinence associated dermatitis.
If whole package not used for clean up, write client's name on package, reseal the label and leave at bedside. Do not put open package into warmer. Discard package if cloths are dry. Do not re-moisten.	To minimize risk of cross-contamination.
Disposal	
Discard each cloth into garbage after use. Do not flush cloths or put in macerator.	Cloths may plug/clog plumbing.
Expected Outcome	
Product performs as expected.	If product does not perform as expected, notify NSWOC/Wound Clinician and consider submitting a Supply Chain Product Concern Form .
